**SPECIAL ANNOUNCEMENT No. 1: MANDATORY E-FILING: AS OF JANUARY 1, 2014, THE TEXAS SUPREME COURT HAS MANDATED ELECTRONIC FILING OF ALL DOCUMENTS IN NUECES, TEXAS. NO PAPER DOCUMENTS WILL BE ACCEPTED EXCEPT AS PERMITTED BY THE SUPREME COURT'S NEW E-FILING RULES. PLEASE REVIEW THE NUECES COUNTY LOCAL RULES OF THE DISTRICT COURTS CONCERNING THE ELECTRONIC FILING OF COURT DOCUMENTS. FINALLY, LEARN ABOUT E-FILING THROUGH [EFILETEXAS.GOV](http://EFILETEXAS.GOV) AND FIND ELECTRONIC FILING SERVICE PROVIDERS (EFSPs).**

All defendants are required to appear at all court settings unless specifically excused by the Judge. All parties must abide by the 214<sup>th</sup> District Court dress code which is posted on the Nueces County website and courtroom doors. Please see bailiff or court manager for any other questions.

### ***Criminal Family Civil***

- **All motions for continuance** must be e-filed and given a seven (7) notice to all parties and court coordinator. If the parties would like to amend the docket control order in addition to continuing the hearing date, please note your request in the motion for continuance and include a statement that a new scheduling order shall be issued in the proposed order. ALL continuance or reset motions (whether agreed, unopposed or opposed) MUST state what number continuance motion is being filed (i.e. "Plaintiff's First" or "Defendant's Second" or "Third Agreed Motion," etc.). Continuances after the first continuance must demonstrate substantial need for a delay of the setting.
- **Emergency Motions:** If emergency arises, file your motion and request for emergency hearing directly with the court coordinator. Additionally, please give the courts an oral overview of the nature of the emergency. The court coordinator will advise the parties of the date and time for an oral hearing or telephone conference after the conferring with the Court.

### ***Criminal***

- **Arraignment:** The court does not accept Waiver of Arraignments.
- **Pre-trial Motions:** Pre-trial hearing shall be scheduled not to be less than two (2) weeks prior to trial.
- **All other Motions:** All matters set out in Article 28.01 T.C.C. P
- **Docket Calls:** Defendants are required to attend Docket Call.
- **Jury Trial:** The Court does NOT accept plea agreements on the day jury trial is set. The Defense attorney is responsible for ensuring that the defendant has clothes for trial and must follow Nueces County Jail procedures for providing clothes to the defendant in custody.
