## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$.112367 per \$100 valuation has been proposed by the governing body of Nueces County Hospital District.

PROPOSED TAX RATE \$0.112367 per \$100
NO-NEW REVENUE TAX RATE \$0.108567 per \$100
VOTER-APPROVAL TAX RATE \$0.118041 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for Nucces County Hospital District from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that Nueces County Hospital District may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Nueces County Hospital District is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on September 02, 2020 at 9:00 AM at Commissioners Courtroom, 3rd Floor, Nueces County Courthouse, 901 Leopard, Corpus Christi, Texas 78401.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Nueces County Hospital District is not required to hold an election at which voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the governing body of Nueces County Hospital District at their offices or by attending the public meeting mentioned above.
