
HEREIN, the Nueces County Clerk's office will provide and facilitate a full service election for Calallen ISD.

HEREIN, all residents determined to be qualified voters of said District shall be entitled to vote at said election.

HEREIN, this Order shall serve as proper Notice of said election, and this said Notice shall be published one time by said District, not earlier than the 30<sup>th</sup> day or later than the 10<sup>th</sup> day prior to the date set for the election, in a newspaper of general circulation in said District. In addition, said Notice will be posted on a bulletin board used for posting notice of meetings of the Board of Trustees not later than the 21<sup>st</sup> day prior to the date set for the election.
