Emergency Financial Assistance Program for Eligible Nueces County Veterans, Dependents, and Surviving Spouses

# NUECES COUNTY VETERANS' ASSISTANCE GRANT PROGRAM



The program provides emergency financial assistance to eligible Nueces County veterans, their dependents, and surviving spouses.

Eligibility income guidelines and other criteria have been established to determine the need for emergency assistance.

Emergency assistance includes basic life needs such as mortgage/rent, utilities (water, gas, electricity), food and transportation.

**Veterans** must be a Nueces County resident & have an Honorable Discharge or a General, Under Honorable Discharge. **Dependents** must be a dependent of an eligible veteran and a Nueces County resident (Dependent is defined as a child, step-child, or legally adopted child under 18 years of age); disabled adult child who requires care by an adult; adult child attending college full-time and under 23 years of age. Legal spouse; **Surviving Spouses** must have been legally married to an eligible veteran and must not have re-married.

## APPLICATION PROCESS

Initial eligibility will be determined at the Veterans Services office. If you meet the minimum eligibility requirements, you will then be referred for final determination of eligibility.

Final eligibility is determined by the Nueces County Department of Social Services also located on the 1st floor of the Regional Transportation Authority (RTA) building.

Please bring the following items with you:

- ◆ Copy of your DD214, showing an Honorable Discharge or General, Under Honorable Discharge
- ◆ Valid picture identification such as Driver's License, State Issued I.D. or Military I.D.
- ◆ Social Security Card
- ◆ Marriage License/Declaration of Informal Marriage/Common Law/Death Certificate
- ◆ Current mortgage statement, rent receipts or copy of lease agreement
- ◆ Current utility bills
- ◆ Proof of income for the past 30 days for all household members, including but not limited to check stubs, letter from employer, Social Security, SSI and VA, unemployment or worker's compensation, etc.
- ◆ Proof of work search for all employable members of household (if unemployed)

- ◆ If disabled and under doctor's care, you must provide a current medical report.
- ◆ If your household is eligible for TANF benefits, you must provide proof of application.
- ◆ If applying for food assistance, you must provide proof of pending SNAP application.

**Other information may be requested.**



Please note that this program is grant-funded and subject to the availability of funds.

The purpose of the Nueces County Veterans' Assistance Grant Program is to satisfy the unmet, emergency financial needs of Nueces County veterans, their families, and veterans' surviving spouses. **It is not an entitlement program based on veteran status.**
