**WHEREAS**, this Board of Trustees deems it advisable to call the election hereinafter ordered; and

**WHEREAS**, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place, and purpose of the said meeting was given as required by Texas Open Meetings Act, Texas Government Code, Chapter 551.

**THEREFORE, BE IT ORDERED BY THE FLOUR BLUFF INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES THAT:**

An election is to be held on November 5, 2024, for the purpose of:

**Early voting will be conducted during the period of time as required/permitted by law.**

**HEREIN**, the Nueces County Clerk's office will provide and facilitate a full-service election for Flour Bluff ISD.

**HEREIN**, all election officers, Presiding Judges, and Alternate Presiding Judges designated by the Nueces County Clerk's Office are hereby appointed and confirmed to hold said election at said polling places.


**HEREIN**, all residents determined to be qualified voters of said District shall be entitled to vote at said election.



**This Order is issued on the 27th day of June 2024, and in all respects, said election shall be conducted in accordance with Texas state law and Texas Election Code.**






