On this 12th day of August, 2024, the Board of Trustees of the Corpus Christi Independent School District convened in a regular meeting at the School Administration Building, 801 Leopard Street, Corpus Christi, Texas, after due notice to all members of the Board. A quorum being present, the following business, among other business, was transacted.

Eric Villarreal introduced for consideration an order and moved that it be made, adopted and entered by the Board. The motion was seconded by Dolly Gonzales Trolley . The order was discussed and then made, adopted and entered by the following vote.

The President of the Board announced that the order had been duly made, adopted and entered as follows:

It is hereby **ORDERED** by the Board of Trustees of the Corpus Christi Independent School District, Nueces County, Texas (hereafter at times referred to as the "District"), that:

1. An election be held in said Corpus Christi Independent School District on November 5, 2024, (such date being the first Tuesday after the first Monday in November 2024, for the purpose of electing four members to the Board of Trustees of the Corpus Christi Independent School District to hold Single Member District Two Position and Three (3) At-Large Positions on such Board. The single member district candidates receiving a plurality of the votes cast by electors residing in Single Member District 2, as designated on Page 1 of 8

Exhibit A, attached hereto and made a part hereof, shall be elected as the Single Member District 2 Trustee. The three At-Large candidates receiving the highest number of votes cast by electors residing in the entire district shall be elected to the three (3) At-Large Positions.

- 2. Brian S. Nelson, whose office is situated at 801 Leopard Street, Corpus Christi, Texas, is hereby appointed the official for the district for conducting the election as permitted by law, and he is hereby authorized and directed to make all necessary arrangements for the holding of said election and to serve as representative to oversee and coordinate with the County Election's Manager in conducting the election in accord with and subject to the laws of this State. Brian S. Nelson is appointed to hold such election in accord with the laws of this State.
- 3. In order to have his/her name appear on the official ballot, each candidate shall not later than 5:00 o'clock p.m., August 19, 2024, file his/her written sworn application as a candidate for such office with Brian S. Nelson, electronically at electronically.coisd.us or at his office at 801 Leopard Street, Corpus Christi, Texas.
- 4. The order in which the names of the candidates shall appear on the ballot shall be determined by drawing lots, which drawing shall be held in the Board Room of the District Administration Building, 801 Leopard Street, at 10:00 a.m., on Monday August 26, 2024. Each candidate may appear in person or by his/her duly authorized representative at said time and place for the purpose of drawing lots to determine such order; and, if candidate fails to appear in person or by his/her representative, a disinterested person shall then be appointed to draw him/her in his/her place and stead.
- 5. No party designations shall appear on the official ballot of said election and all candidates for each office of trustee shall be listed in one column.
- 6. The voting places for this election are hereby designated to be those set forth on the instrument attached hereto and marked Exhibit A, which instrument is incorporated herein and made a part hereof.
- 7. Voting machines provided by the Nueces County Elections Department shall be used for the conduct of said election on Election Day, and the polls shall be open 7:00 a.m. to 7:00 p.m.
- 8. Early voting by personal appearance shall be conducted at the Exhibit A locations and times, as modified and to be determined during the hours from 8:00 a.m. to 5:00 p.m., beginning October 21, 2024, and continuing through November 1, 2024, during the hours from 8:00 a.m. to 5:00 p.m. on each day which is not an official State holiday; except that, early voting by personal appearance shall also be conducted on Saturday, October 26, 2024, during the hours from 7:00 a.m. to 7:00 p.m. and Sunday, October 27, 2024, during the hours from 12:00 p.m. to 5:00 p.m. Modifications of early voting times for the appropriate Page 2 of 8

weekends and locations to be determined and provided by Nueces County at a later date. Ms. Kara Sands, Nueces County Clerk, is hereby designated the Early Voting Clerk. Deputy early voting clerks for the branch locations for early voting by personal appearance shall be appointed by the County Clerk. The main early voting location is the Nueces County Courthouse.

- 9. Temporary branch early voting locations and times maybe designated by and determined and provided by Nueces County at a later date.
- 10. Early voting by mail shall be conducted by paper ballot. The Early Voting Clerk's mailing address to which ballot applications and ballots voted by mail may be sent is:

Applications for ballots by mail must be received no later than 5:00 pm on Friday, October 25, 2024.

- 11. A Central Counting Station will be used to process the results of the early voting ballots. Diane Munguia is hereby designated as Counting Station Manager, Presiding Judge of such Central Counting Station and Nueces County Election's Manager. Kenneth Villarreal is hereby appointed as Tabulation Supervisor of this Central Counting Station.
 - 12. Notice of said election shall be given as required by law.
